

# Khmer Enterprise – Enterprise Agriculture Cooperative Incubation Programme

From June to Aug 2021, CPSA's Enterprise ACs team has achieved some results against set milestones. Firstly, Impact Hub completed a training curriculum for participants of batch 1.

Furthermore, the recruitment of participants for batch 1 was completed; consequently, there were 24 youths selected (17 youths from 10 universities and other 7 local youths from 5 targeted ACs areas). Most of the students graduated in 4the year and recently finished their studies.

In fact, there were some guest speakers identified to deliver training for batch 1. Mostly, they all are coming from private sectors, INGO/NGOs, government agencies, and research institutions/universities. Those speakers were important to connect theory and practice in the areas of expertise to all participants.

### **ASEAN RAI**

In this quarter, we are working closely with Grow Asia on finalizing the private sector case studies of the three companies in our network. Our team also joined the ASEAN RAI focus group discussion as a facilitator to collect inputs from RAI stakeholders on the RAI learning program development.

### **MRLG**

During this quarter, some fruitful achievements include the literature review of contract farming and inclusive business in the region is finalized and submitted to the Alliance members then the document will be translated into Khmer before sharing with our network. Additionally, case studies and a video documentary regarding farmers' responsible agriculture investment experience are developed. Similarly, private sector engagement strategies and situation analysis have been making more progress as well and it is expected to complete it by December 2021.

# COMMUNICATIONS AND VISIBILITY

Coming to this 3rd quarter of 2021, a lot of progress and updates have been made by our CPSA team. In order to keep our partners and public audiences informed, our Communications team at CPSA has been dedicating more effort to enhance our social media presence and communication channels.

Our team also issued the 2nd Quarter newsletters as well during this quarter to inform and provide a brief but precise summary of our works and past accomplishments.

Director of Rice Holice and Koii Food Creator. Both parties exchanged ideas on the Koji process and application and one key important note is that Rice is the best ingredient for Koji. In addition to that, we also discussed the cashew sub-sector where Top Planning (Cambodia) has invested in building a processing factory in Kampong Thom. Besides that, we also exchanged on the potential Agro-Processing Zone concept. Mr. Ratha also shared his experience in working with multi-stakeholder in agriculture and how we could link up/support the potential investment in agri and agro investment projects in Cambodia. Lastly, Japanese delegates really appreciated the insight of the CPSA Director and looking for further collaboration in the future.
